REQUEST FOR RELEASE OF FUNDS

On or about March 8, 2017 the Town of Chilhowie will submit a request to the Virginia Department of Housing and Community Development (DHCD) for the release of Community Development Block Grant funds under Title I of the Housing and Community Development Act of 1974(PL 93-383), as amended, to undertake a project known as Chilhowie Downtown Revitalization Project, for the purpose of Town-wide revitalization through the elimination of physical blight, removal of barriers to economic revitalization, promotion of private economic investment and restructuring of the Town's economic base. This project will assist the Town in the overall revitalization efforts needed to attract residents, visitors, and entrepreneurs.

FINDING OF NO SIGNIFICANT IMPACT

The <u>Town of Chilhowie</u> has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. All comments received by <u>March 5, 2017</u> will be considered by the <u>Town of Chilhowie</u> prior to authorizing submission of a request for release of funds. Commenters should specify which part of this Notice they are addressing.

RELEASE OF FUNDS

The <u>Town of Chilhowie</u> certifies to DHCD that <u>John Clark</u> in his capacity as Town Manager consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. DHCD'S approval of the certification satisfies its responsibilities under NEPA and related laws and authorities, and allows The Town of Chilhowie to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

<u>DHCD</u> will consider objections to its release of funds and the <u>Town of Chilhowie</u> certification received by <u>March 18, 2017</u> or a period of fifteen days from its receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer or other officer of the <u>Town of Chilhowie</u> approved by DHCD; (b) the (RE) has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient or other participants in the project have committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by DHCD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58) and shall be addressed to DHCD at:
